- **4.** New monthly fees
  - i) 3 day program increases to \$145 per month from \$130

- ii) 2 day program increases to \$110 per month from \$95 motion to approve: Danielle Anderson; seconded by Zinnie Breitkreutz; all in favor; none against; motion passed
- **5.** One mandatory fundraiser to be done within the first month of the school year for every registered family with optional throughout the rest of the school year

  - motion to approve Wendy Ahlefeldt; Seconded Ben King; motion approved
